Analysis (w/w):

Boron (B) -8% Manganese (Mn) -2% Magnesium (as MgO) -6% 0.1% Zinc (Zn) -Nitrogen (as N) -4% Molybdenum (Mo) -0.04% 13% Sulphur (as S) -

Mixing Procedure:

- 1. Half-fill the spray tank with clean water and start agitation.
- 2. Add the required amount of MULTIPLEX II to the tank and allow to disperse and dissolve.
- 3. Add the remaining volume of water together with any agrochemicals.
- 4. Commence spraying, keeping the agitator switched on thoroughout the spraying operation.
- 5. DO NOT allow the mixture to stand for long periods prior to use.

Timing:

Apply at, or just prior to, periods of rapid crop growth.

* Maximum of 2 applications per crop. DO NOT APPLY after G.S. 45 (Zadoks). Multiplex II is effective at lower water rates but is best applied in 2-300 l/ha of water.
