Application Rates:

3.0L - 5.0 L/Ha depending on need
Apply UPLIFT at the first signs of stress.
Repeat applications may be required in extended stress conditions.
Apply in 80 - 200 l/ha, depending on crop treated

Crops:

UPLIFT can be used on a wide range of crops including cereals oilseeds potatoes peas beans maize

Tank Mixing:

SHAKE WELL BEFORE USE - This product is widely compatible with other chemicals and will disperse in water with a little agitation. If in doubt, consult your advisor of follow this sequence:

- 1) Water
- 2) Pesticide
- 3) Uplift

If applications are to be made to crops under severe stress avoid tank mixes with pesticides that have the potential to scorch the crop. Test physical compatibility by mixing a small amount of the proposed mix in the ratios to be used in a small container before performing the operation in the spray tank.
For best results during hot weather spray early morning or late evening.
